

OFFICIAL RULES: GOOSEBUMPS TRIVIA FACE-OFF

1. **NO PURCHASE NECESSARY.** To enter, the parent or guardian must answer the questions presented on the GOOSEBUMPS TRIVIA FACE-OFF entry form on behalf of the participating student. All entries must be submitted via this Google form: <https://bit.ly/3J8P0LT>. Contact email addresses given on the form must belong to the parent or guardian of the entrant. All entries must be received by 11:59 p.m. on October 10, 2022. No other means of entry accepted.

2. Winners will be selected based on the quality and originality of the fact that they share about Goosebumps. All entrants must be available for a rehearsal using the StreamYard app (Chrome required) on a date to be determined prior to the Virtual Author Visit, as well as between 12:00 p.m. EST and 2:00 p.m. EST on the date of the actual livestream Virtual Author Visit, which is Thursday, October 27, 2022. The Virtual Author Visit will take place between 1:00 p.m. and 1:30 p.m. EST. Winners not available for those dates and times will forfeit their prize. The entrant's comfort level with speaking in public and virtual communication will also be considered. Winners will be notified on or about Thursday, October 13, 2022. Scholastic Book Clubs, Inc. ("Sponsor") is not responsible for late, lost, misdirected, or incomplete entries.
